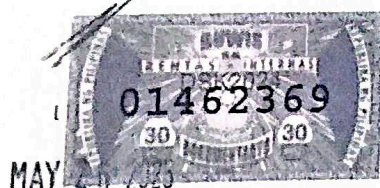

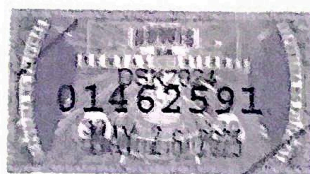
1. That I am **NATHANIEL R. ERNI** not gainfully employed since I am still a student and thus, I only have my savings enough for me;
